Full Moon paddles. July and October the SRWA hosted full moon paddles in the Somersville Mill Pond. At the July event Eastern Mountain Sports offered instructions in their kayaks. 30 canoes and kayaks enjoyed a warm summer evening paddling with a

clear sky by the light of the silvery moon (and a few glow sticks!). The fall paddle was threatened by a heavy rainstorm. A half hour before the event the skies cleared and a hearty crew enjoyed a nice paddle and brief appearance of a full moon.

Hiking has become very popular. The December hike explored from the Scantic Recreational Park in Scitico to the Somersville Mill Pond. Judy Snyder started the New Year with 35 hikers on the new Schlatz trail in Somers. In February Rex Joffray led

65 hikers from the State land at Bailey road to the Somersville Mill Pond . The trail followed the old historic canals and remnants of the Enfield Power Company

River Cleanup and Water Testing

The annual Wadeable Stream ity samples taken. Project held in October was led by Mike Dynia and biologist Kirsten Martin. A mobile laboratory was setup along the Powder Hollow section. The results continue to be positive from the water qual-

The Source to Sea Project in September was organized by Betty Slanetz and cosponsored by the SRWA. 35 participants removed over 4.5 tons of garbage from the Enfield river banks.

River Cleanup is a continuous task for the SRWA with volunteers removing tree falls and other obstructions from the river. We need your help cleaning up the river! A very active beaver population has created dams along the river.

Note: Beavers and their dams are protected by state statute. Please contact the SRWA or the CT DEP for more information.

Watershed Activity - President Patrick Sharron

Springborn Dam Removal:
The Connecticut DEP, Connecticut River Watershed
Association, American Rivers and SRWA are working on a project that would remove the Springborn Dam in Enfield. The engineering firm Fuss and O'Neill have been chosen to provide a feasibility study to report on the impact and cost of removal.

In December Fuss & O'Neill dropped a barge into the river by the dam and took test borings of the sediment. Official test results should be available soon.

The SRWA supports a full removal of the dam for safety reasons, for enhancement to recreational activities and encouraging for the migration of fish.

River Access and protection:

Dick Sherman has made great progress with the State, Town of East Windsor and property owners to provide access and land protection from the Filter Bed section to Omelia Road.

The SRWA has participated in town council meetings in Enfield to oppose zoning changes that would create

escarpment issues.

In January 2008 the SRWA supported the DEP's proposal to add a small parking lot at 464 Hazard Avenue in order to provide another access point to the river. Cheers, Pat!



Scantic Greenway Nomination - Jan Collins and Rex Joffray

The SRWA has submitted a nomination for **Greenway Designation** with the DEP

Greenways Council for the section linking the Enfield

Powder Hollow area to the Somersville Mill Pond. The SRWA believes that this area

is very important to be recognized as a Greenway for resource protection, historic preservation, land conservation, improvement on recreational activities and access to the river. The SRWA has applied for a \$5,000 Green-

way grant to assist in the planning, development and implementation on the proposed Greenway. We are very grateful for many letters of support from State officials, Town officials and local organizations. Thank you!

We will keep you posted on the outcome of our nomination.


